Engaging in Equity Driven Leadership Development in Health Care Systems and Health Care Education: Why, How, and Now

Changing the Game: Redesigning Our Approach to Mental Health in a Post-COVID-19 WorldBenjamin Miller, PsyD, Well Being Trust, Chattanooga, TN

COVID-19 has been a helpful magnifying glass. In sharp relief, we see significant levels of anxiety and depression, overdoses, dependency on drugs and alcohol, loneliness and despair, self-harm and suicide, and a startlingly increase of these issues in our youth. Survey after survey show the negative impact COVID-19 has had on our collective mental health. We did everything we could to get through the pandemic, but was it enough? For our nation's mental health, the answer seems to be no. With more

shots in arms, what will we do differently? The status quo wasn't working for most people before COVID-19, and now we have a moment to reconsider what a post-COVID system looks like for mental health. How can we collectively come together in service to advancing a new approach to mental health care—one for, by, and in community?

This presentation will highlight many of the mental health problems we all saw and felt during COVID-19 and offer solutions for, not only addressing the increase in mental health need that we've experienced, but also creating a proactive system of care that prevents us from teetering on the brink of mental health crisis in the future. From clinical to policy recommendations, this presentation will challenge us to rethink how we approach mental health and addiction from our clinics to Congress.

Failing Forward

Shawn Martin, American Academy of Family Physicians, Leawood, KS

For decades, we have posited that numerous health care policies have failed to achieve a set of agreed upon objectives. But what if those policies actually did achieve their desired outcomes? What we label "failed" may be what was initially sought. For example, we argue that the GME system has failed to properly support family medicine. As it wasn't designed to support family

medicine, the system hasn't failed by design, even if it has failed outcomes. How do we introduce policies that advance a new construct of public policy more aligned with outcomes? What if failed policies led us to better solutions?

Our team is honored to be the recipients of the H. Winter Griffith Scholarship for Excellence in Practice Improvement in Patient-Centered Care. We would like to share the process we have implemented to improve patient-centered care.

RUHS/UCR Family Medicine Residency values quality and process improvement and has found a way to incorporate it in our curriculum to become well rounded family physicians. During the past two years, our residents have been conducting patient-centered quality improvement projects at our home FQHC, Moreno Valley Community Health Center.

Within our community and within our county, it was apparent that our screening rates did not meet our clinical quality measure goals. With the supervision of our faculty, our residents worked with clinic staff and others on a multidisciplinary team to establish unique projects to improve screening rates in cervical cancer, hepatitis C, and osteoporosis.

Our green team worked on cervical cancer screening. Given that many of our quality measures and screening rates were devised through our EMR in accordance with Healthy People 2020 objectives, we wanted to understand how the data was gathered and reported. We felt that this was important to learn because, as physicians, we incorporate data and research to guide our clinical practice every day. Evaluating the quality of the data from research is also a continual practice we must learn. We discovered discrepancies in the screening rates which helped prevent unnecessary tests on our patients. Subsequently, we reached out to patients in our community who were eligible to receive cervical cancer screening through a multimodal approach (phone calls, letters, email messages) which shown a significant improvement in our screening rates.

We hope to continue these projects but with different approaches in the future.

Project: Rapid Deployment of COVID-19 Vaccine in a Primary Care Clinic

OHSU Scappoose Primary Care Clinic is located in rural Oregon. As the COVD-19 vaccine was rolled out nationally, there was no existing public infrastructure to distribute the vaccine in Columbia County with approximately 52,000 residents. The county public health system had no space, infrastructure, or expertise to vaccinate the entire population.

Dr. Brian Garvey, MD, medical director, Dr. Joe Skariah, DO, Columbia County public health officer, and Stein Berger, practice manager, spearheaded a public/private partnership to rapidly deploy COVID-19 vaccine provided to the county using the existing clinic infrastructure and expertise. The clinic was converted to a vaccine clinic on the weekends (with eventual evening availability during the week) and offered an efficient system for scheduling, vaccinating, conducting post-vaccine monitoring, and coordinating second dose follow-up visits. At the time this nomination was written, the Scappoose Clinic had delivered more than 17.000 vaccines to the residents of Columbia County.

Leveraging technology, clinician expertise, and community partners, this model was very successful and could be applied to almost every family Medicine clinic in the nation. The efficient delivery model developed at Scappoose has since been rolled out to other primary care clinics in the OHSU system.




